

## WEEK 3 TEST

### RULE 6.1.6

1. K1 FREE KICK FROM K'S 40 YARD LINE IS MUFFED BY R18 NEAR HIS 35 YARD LINE. THE MUFF IS CAUGHT BY K56 AT R'S 38 YARD LINE AND HE ADVANCES FOR A TOUCHDOWN.
  - A. LEGAL TD FOR K.
  - B. KCI ON K56 15 YARD PENALTY
  - C. K'S BALL 1 AND 10 FROM R'S 38 YARD LINE

### RULE 6.1.11

2. K1 EXECUTES A POP-UP KICK FROM THE K40 IN A FREE KICK SITUATION.
  - A. 5 YARD LIVE BALL PENALTY RE-KICK FROM K35
  - B. 5 YARD DEAD BALL PENALTY RE-KICK FROM K35 OR DECLINE DISTANCE PENALTY AND RE-KICK FROM K40
  - C. NO PENALTY

### RULE 6.2.3

3. TRUE OR FALSE  
ANY K PLAYER MAY CATCH OR RECOVER A SCRIMMAGE KICK WHILE IT IS IN OR BEHIND THE NEUTRAL ZONE AND ADVANCE, UNLESS IT IS DURING A TRY.

### RULE 4.2.2

4. TEAM A IS TRAILING TEAM B 17-14 WITH 1:00 MINUTE LEFT IN THE 2ND QUARTER. TEAM A LINES UP FOR A FIELD GOAL TRY FROM THE B 13 YARD LINE. A13 HAS ONE KNEE ON THE GROUND TO HOLD FOR AN APPARENT FIELD-GOAL ATTEMPT. A13 CATCHES THE SNAP AND WITHOUT RISING, FLIPS THE BALL TO A44 WHO RUNS IN FOR A TD. RULING?
  - A. TD FOR TEAM A
  - B. BALL IS DEAD IMMEDIATELY AFTER A13 FLIPS THE BALL
  - C. ILLEGAL FORWARD PASS 5 YARD PENALTY AND A LOSS OF DOWN

### RULE 4.3.5

5. K'S FREE KICK OUT OF BOUNDS AT R'S 8 YARD LINE. R ACCEPTS THE PENALTY AND WILL PUT THE BALL IN PLAY NEXT AT R 35 YARD LINE.
  - A. R MAY PUT THE BALL IN PLAY ANYWHERE ON THE 35 YARD LINE
  - B. AT THE NEAREST HASH MARK WHERE THE BALL WENT OUT AT
  - C. WHEREVER THE UMPIRE FEELS LIKE IT

RULE 2.25.10

6. TRUE OR FALSE

A POP-UP KICK IS A FREE KICK IN WHICH THE KICKER DRIVES THE BALL IMMEDIATELY INTO THE GROUND, THE BALL STRIKES THE GROUND ONCE AND GOES INTO THE AIR IN THE MANNER OF A BALL KICKED DIRECTLY OFF THE TEE.

RULE 6.4

7. TRUE OR FALSE

A SCRIMMAGE KICK RECOVERED BEYOND THE NEUTRAL ZONE MAY BE ADVANCED BY BOTH K AND R.

RULE 6.2.3

8. A SCRIMMAGE KICK BY K11 IS PARTIALLY BLOCKED IN THE NEUTRAL ZONE BY R22. THE KICK GOES BEYOND THE THE NEUTRAL ZONE WHERE R8 MUFFS IT BACK BEHIND THE NEUTRAL ZONE. K81 RECOVERS BEHIND THE NEUTRAL ZONE AND ADVANCES FOR A TD.

- A. B'S BALL WHERE K81 RECOVERED IT
- B. A'S BALL WHERE K81 RECOVERED IT
- C. TD FOR K LEGAL PLAY

RULE 2.27

9. TRUE OR FALSE

A MUFF IS THE TOUCHING OF A LOOSE BALL BY A PLAYER IN AN UNSUCCESSFUL ATTEMPT TO SECURE POSSESSION.

RULE 7.2.5

10. TRUE OR FALSE

ON FOURTH DOWN OR DURING A KICK TRY, WHEN A SETS OR SHIFTS INTO A SCRIMMAGE-KICK FORMATION AT LEAST 5 "A" PLAYERS ON THEIR LINE OF SCRIMMAGE MUST BE NUMBERER 50-79.
